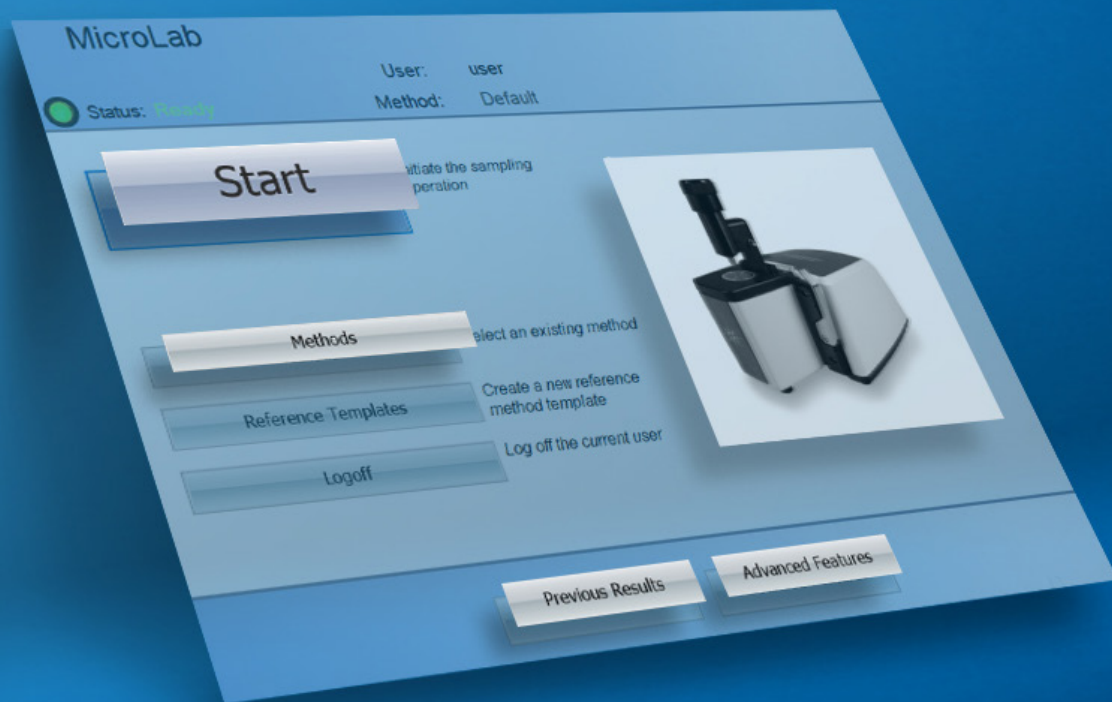

Fourier transform infrared spectroscopy (FTIR) is a quick, easy, and reliable technique for material identification and quantification of components in a sample.



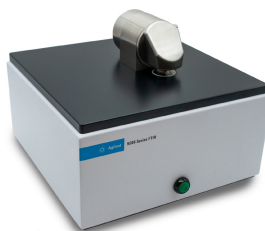

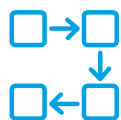

MicroLab software features



Step-by-step guidance using instructive pictures and an intuitive software design allows easy navigation through the entire workflow, for less training and fewer user mistakes.



MicroLab automatically identifies the connected instrument and recognizes the attached sampling module.



The software directly applies the correct parameters and displays the relevant pictures. Permitted modules can be defined for each method.



Eliminate doubts due to data interpretation from routine workflows: after data collection, the software directly provides color-coded, actionable results, making interpretation simple.



Expand the fast and simple software experience to model development for quantitative applications: MicroLab Quant software assists experts and nonexperts through each step in building a quantitative model, and provides instant feedback when optimizing the model.



Report all relevant results: MicroLab incorporates predefined and customizable report templates. Results can be automatically reported, and a consistent format allows swift review of relevant details.

MicroLab software package

To make the use of MicroLab software as easy as possible, the MicroLab software suite includes four individual applications specifically designed for the task at hand:



MicroLab PC

is a method-driven software for collecting and analyzing data using predefined methods.

MicroLab Lite

software can be used for offline review and analysis of FTIR data.

MicroLab Quant

used for simple, easy development and verification of quantification models.

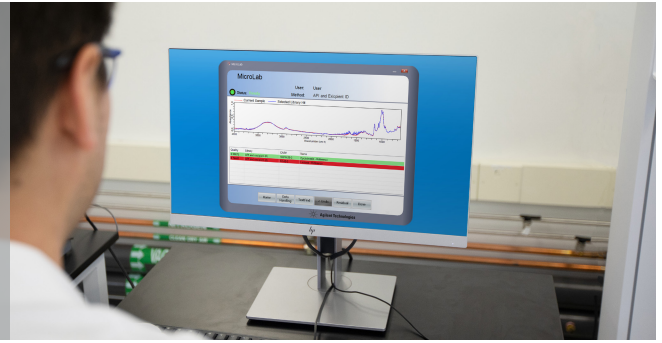
MicroLab OQ

an automated operational qualification (OQ) software that can be used to routinely verify instrument performance.

The optional **Agilent MicroLab Expert** software is ideal when more sophisticated data processing, visualization, and analysis tools are required.

The **Agilent MicroLab Pharma** software is an additional software solution that allows users to manage user privileges and administer secure storage of electronic records. It also facilitates compliance as defined by U.S. FDA 21 CFR Part 11, EU Annex 11, and similar national electronic record regulations.

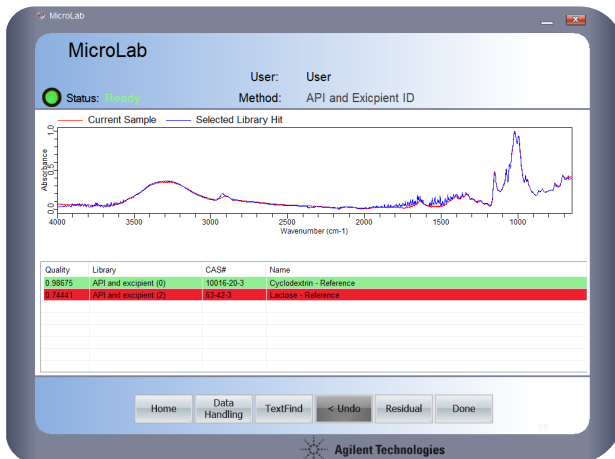


Software method types

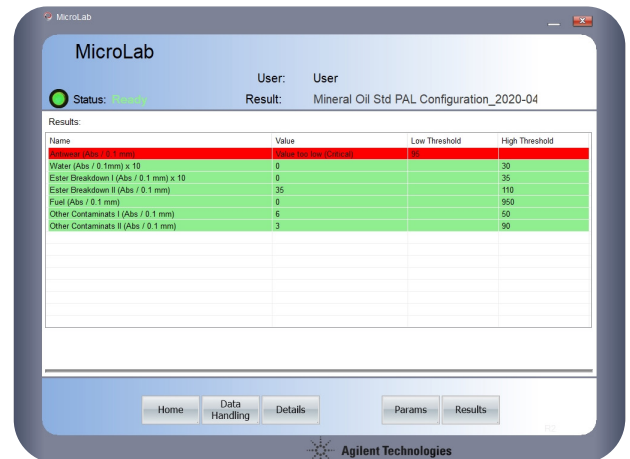
The MicroLab software follows a method-based approach. After the method is set up, the system becomes a turnkey solution.

Three different method types cover the most important analytical questions:

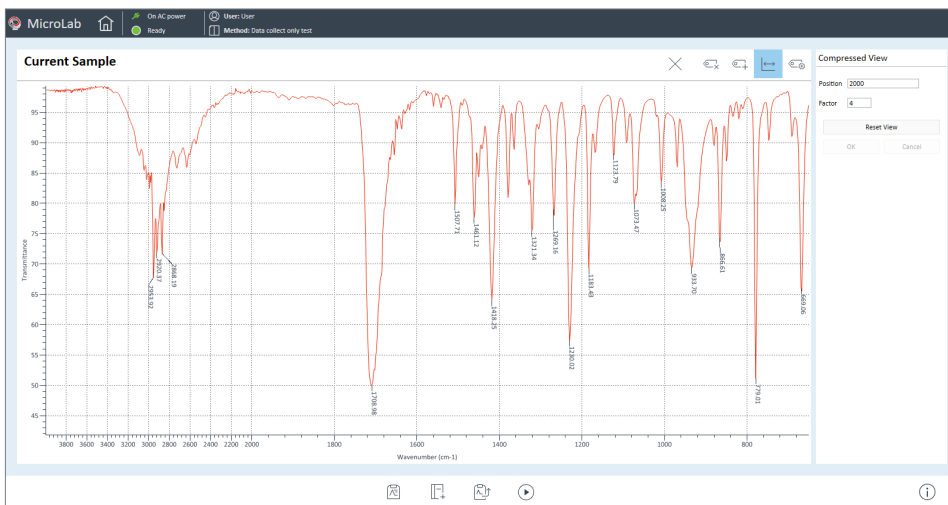
Identification



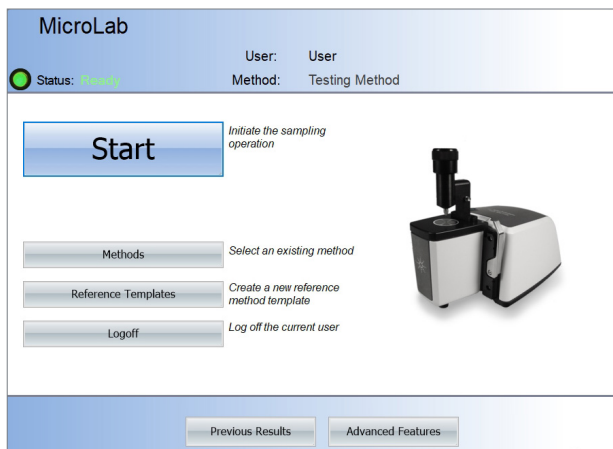
Quantification



Spectrum analysis



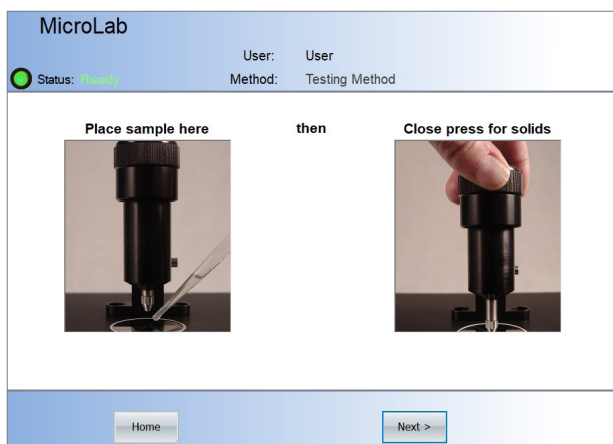
1 Start the analysis



A single click starts a picture-guided workflow that navigates the user through every step of the analysis. The software identifies the instrument and sampling interface in use and displays the relevant images.

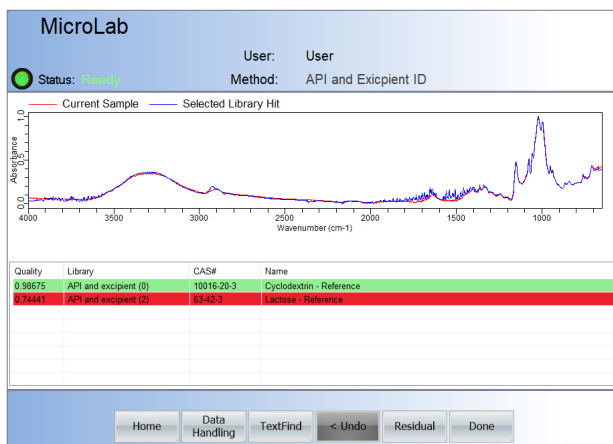


Figure 1. Three simple steps using Agilent MicroLab software and Agilent FTIR spectrometers that make performing an analysis straightforward, with reduced training needs.

After data collection, MicroLab performs all calculations and presents results that are easy to understand, even for novice users. MicroLab software provides color-coded results, which are reported directly after data acquisition, in line with the critical and marginal threshold settings of the method, as shown in Figure 1.

3 Instantly receive color-coded, actionable results

Identification applications

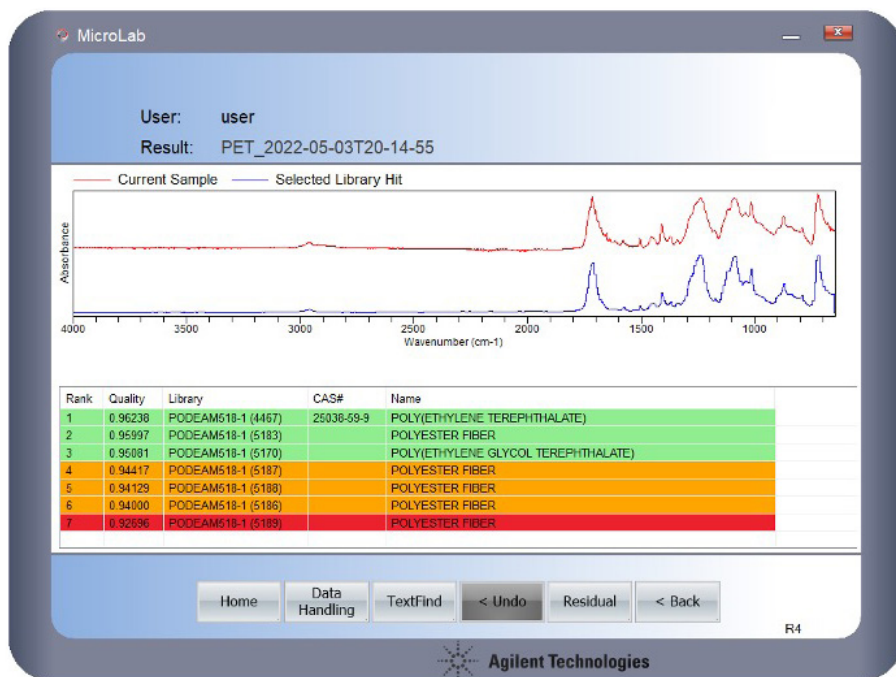


Figure 2. Confirm the identity of your sample by displaying high-quality matches to reference spectra.

MicroLab automatically compares the collected spectrum with a spectral library and finds the best spectral match. For easy interpretation, color-coding can be applied based on confidence levels (Figure 2).

Libraries are easily employed in MicroLab software.

- Agilent provides ready-to-use, application-specific libraries.
- Users can create their own libraries in seconds.

Library searches can be tailored to the identification application.

- Multiple libraries can be searched simultaneously, for example one library with reference standards to identify the sample, and another library with out-of-specification samples to identify re-occurring problems.
- A broad selection of search algorithms is available.
- Spectral ranges can be excluded from the analysis.
- Minimal high quality index (HQI) and maximum number of hits settings ensure only relevant library hits are presented.
- Color-coding of the results based on the HQI can be used to define confidence levels.

Identification is simple with an easy-to-understand display of results.

Examples of applications include:

- Quickly confirming the purity of incoming chemicals and final products.
- Using spectral libraries to quickly authenticate solvents, surfactants, specialty amines, or industrial organic chemicals.
- Identifying narcotic analogs in unknown seized samples.

MicroLab PC and MicroLab Lite

For detection applications, relevant safety and hazard information is clearly displayed in all results windows (Figure 3). Further detailed information can be accessed, including the Custom Information section, which is editable by the user (Figure 4).

Quantification applications

MicroLab allows users to quantify multiple components in a sample with a single FTIR measurement. Basic quantification models can be easily created in MicroLab Quant. For more comprehensive chemometric models, MicroLab also supports prediction models developed in MicroLab Expert.

- **With MicroLab's unique, logic-setting capabilities, only relevant results are displayed.**
- **User-defined criteria for color-coded results (red, yellow, green) provide great flexibility.**
- **MicroLab performs all calculations and instantly provides color-coded, actionable results and follow-up instructions.**

- **Examples of applications include:**

- Ensuring manufacturer's specifications are met by accurately measuring levels of known additives.
- Ensuring blends and mixtures of fine chemicals are properly formulated.
- Obtaining fast, easy, and reliable measurements of liquid samples using transmission FTIR.

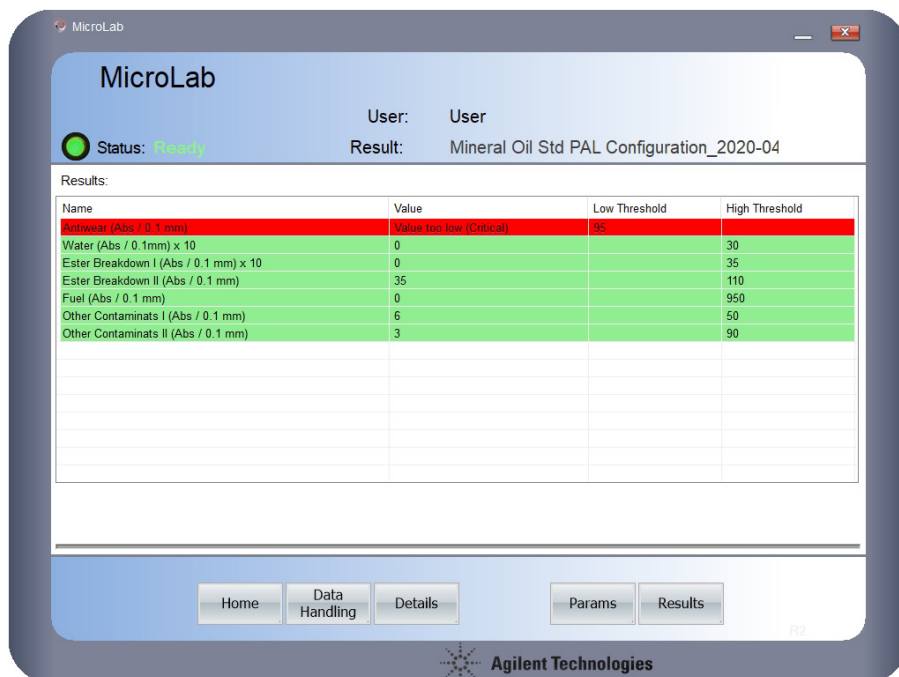


Figure 5. The MicroLab software automatically performs all calculations and displays the final result color-coded for easy review.

Collect and review infrared spectra

MicroLab can also be used to collect and review an infrared (IR) spectrum of a sample. An IR spectrum can provide valuable insights such as the presence of functional groups.

- MicroLab allows users to change the wavenumber scaling factor for a more detailed analysis of the spectra range of interest.

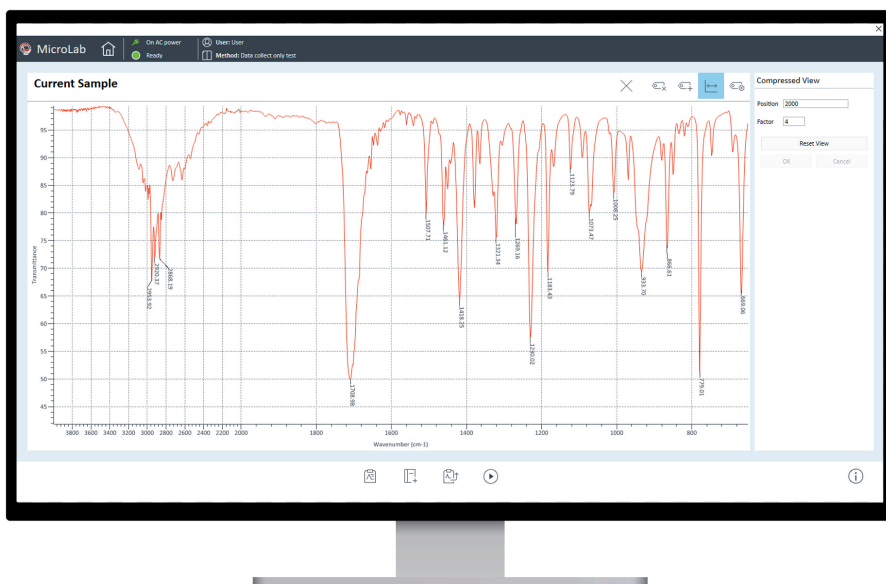


Figure 6. MicroLab software allows operators to collect, review, and re-analyze infrared spectra of samples, along with a reporting feature.

- Bands can be labeled for reporting or comparison against literature values (Figure 6)

Report all your results

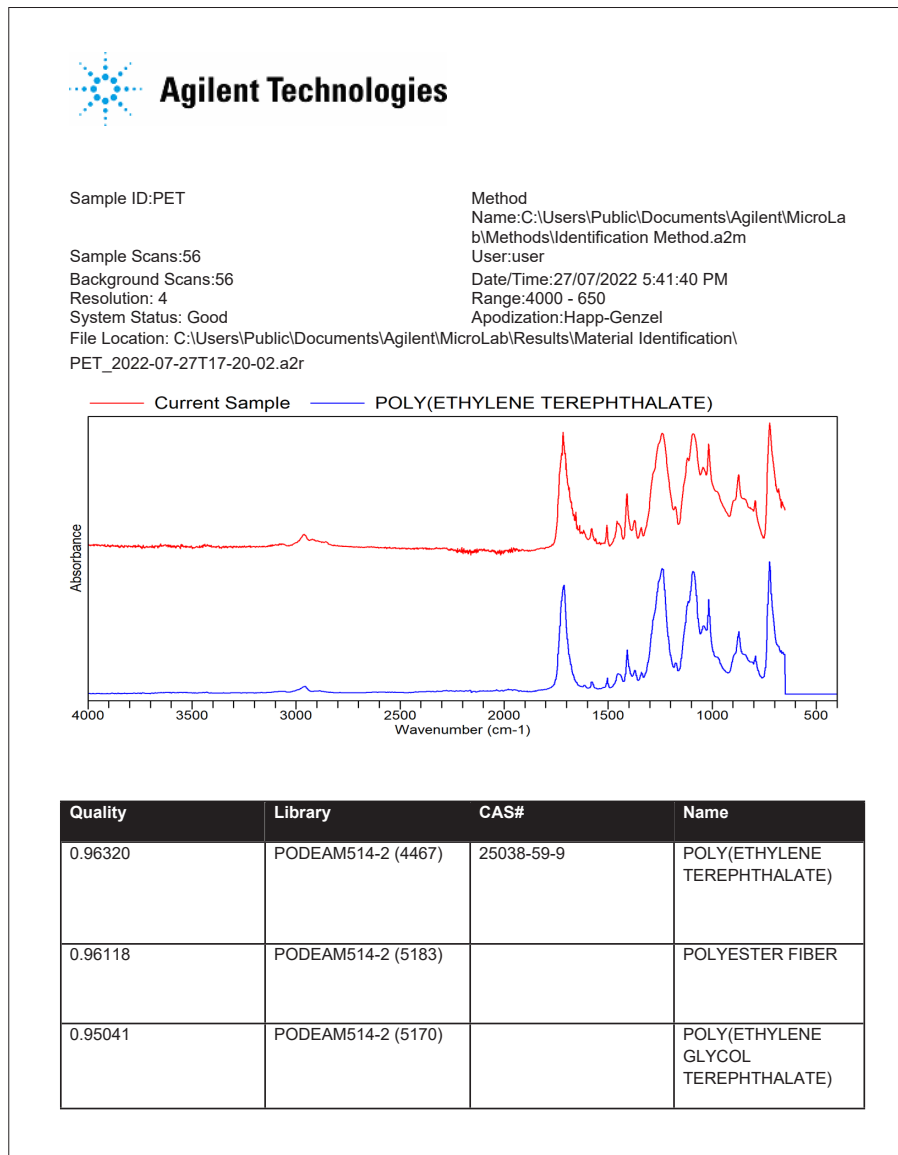
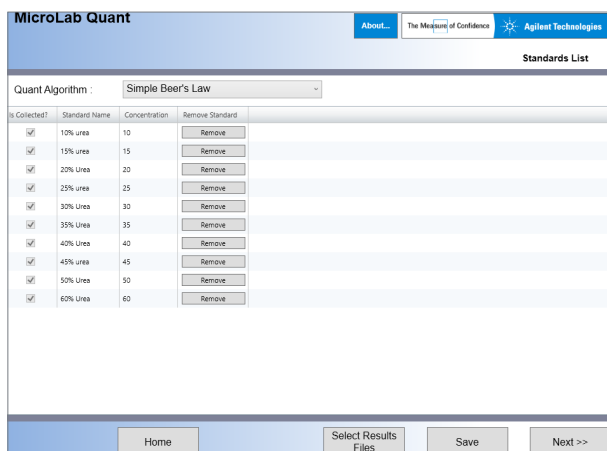


Figure 7. Results report generated using MicroLab software. All relevant details of the analyzed sample can be captured in the generated report for record keeping.

MicroLab PC and Lite incorporate predefined and customizable report templates. Results can be automatically reported, and a consistent format allows swift review of relevant details (Figure 7). Report templates can be edited in Microsoft Word.

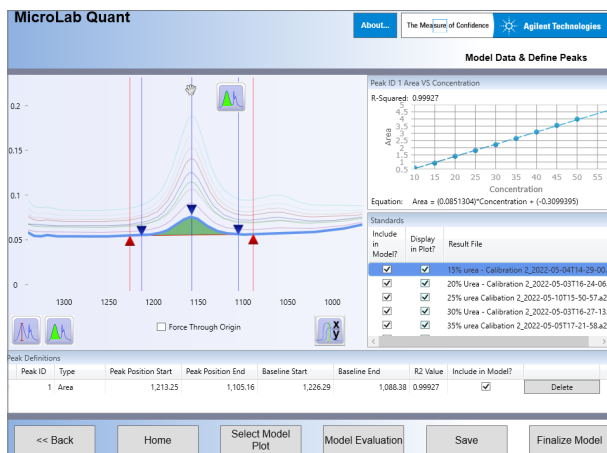
MicroLab Quant

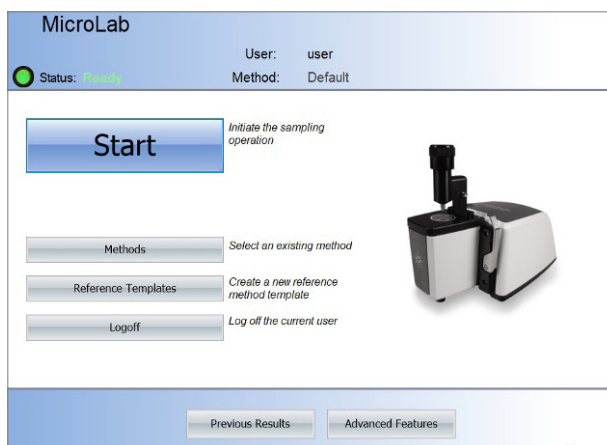


Figure 8. Easy steps of MicroLab Quant software to develop quantitative models.

MicroLab Quant features the same step-by-step guidance as the rest of the MicroLab software suite and expands the fast and simple software experience to model development for quantitative applications (Figure 8). Seamless data integration allows the easy use of IR spectra and quantification models in MicroLab PC, MicroLab Lite, and MicroLab Quant.

1 Select standards and enter concentrations



2 Define peaks and optimize calibration



3 Finalize the model and use it in MicroLab

MicroLab Quant

- The interactive software interface allows swift and easy creation and optimization of quant models (Figure 9).
- Direct feedback shows the influence of any change to the correlation graph.

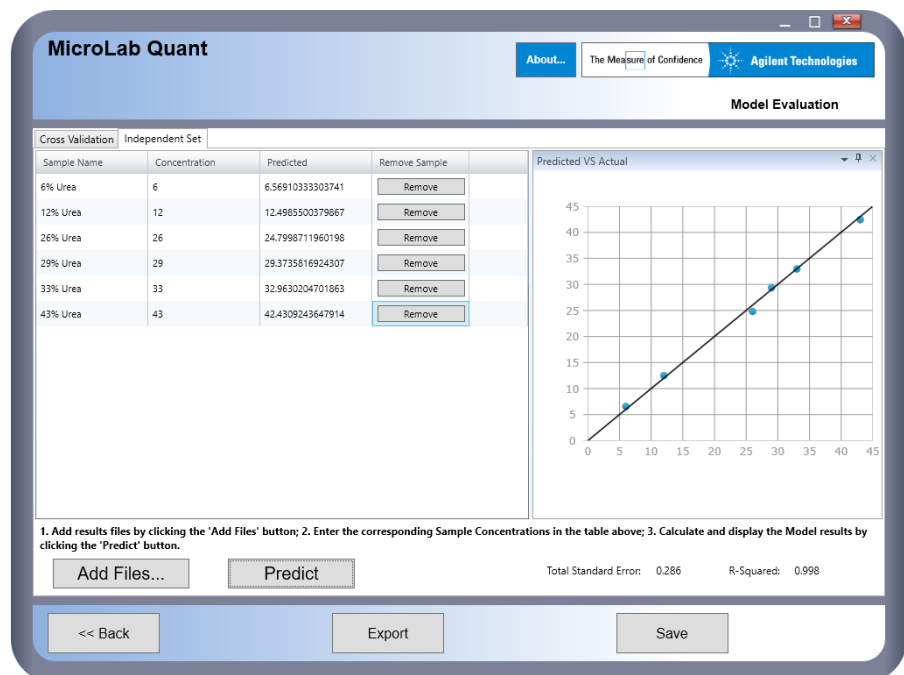


Figure 10. The MicroLab Quant application also allows users to evaluate the developed quantification modules, either through cross validation, or against a separate sample set.

- Quantification models can be evaluated with cross or independent sample validation (Figure 10).

MicroLab OQ

Control of instrument performance is a critical aspect in qualifying an instrument's suitability for the intended analysis.

MicroLab OQ allows users to easily perform instrument performance checks to ensure that an instrument is in good condition.

MicroLab OQ has an intuitive, pictorial interface, which guides users through the qualification process.

1 Select instrument performance tests

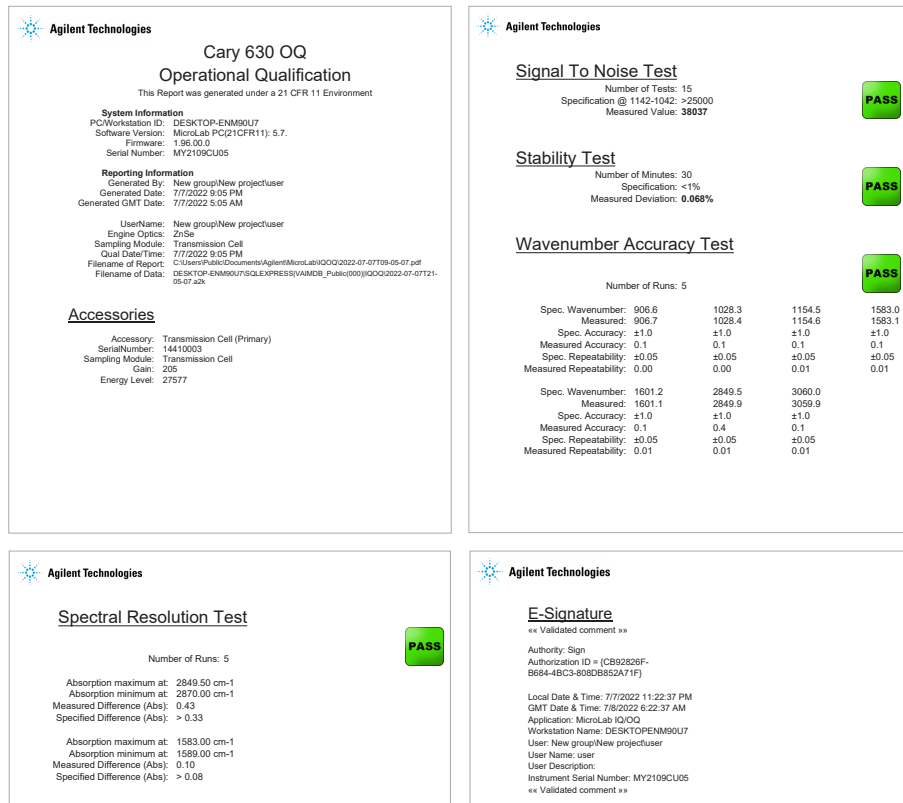


Figure 12. Operational Qualification (OQ) report generated using MicroLab OQ. Results are reported with all test parameters along with easy-to-read pass/fail results.

On the last step, MicroLab OQ generates a PDF report showing the diagnostic values, the test results, and the specifications for the tests and pass/fail criteria for future reference (Figure 12).
